Developing Personal Leadership: Leading the Self Before Leading Others

Workshop Leader: Rita Wuebbeler, Program Facilitator, Saint Mary's University Executive & Professional Development.

With the science and policy of healthcare changing at a frenetic pace in Nova Scotia and across Canada, physiotherapists are increasingly challenged to take on leadership roles in emerging practice settings, and within government, insurance, business, and other "non-traditional" settings. Leadership skills are a critical component of successful navigation of, and negotiation within, today's health system. This workshop focuses on the first critical step of leadership skill development: Personal Leadership.

Our workshop leader, Rita Wuebbeler, is a seasoned consultant and facilitator who has been working with Saint Mary's University since relocating to Halifax last year, developing and delivering team management and leadership sessions. Her consulting practice focuses on maximizing leadership skills within individuals and organizations, in both non-profit and forprofit settings. She will work with participants to build a framework of personal leadership, utilizing group analysis of critical incidents relevant to emerging areas in physiotherapy leadership. The workshop will also assist attendees to develop a personal vision statement for being a leader at work.

Workshop Two:

Functional Exercise Prescription for Disease Prevention and Management

Workshop Leader: Dr. Gail Dechman, PT, PhD, Dalhousie University School of Physiotherapy

Exercise is an effective way to manage or prevent diseases such as hypertension, diabetes, overweight and obesity, and cancer. It forms the cornerstone of cardiac and pulmonary rehabilitation. A recent study identified confidence in the ability to prescribe exercise as one of the top three determinants of whether patients received activity counseling. Because patients often need more guidance than is given in a typical recommendation to increase physical activity, physiotherapists should be able to explicitly prescribe exercise.

This workshop will give participants the theory and practical skills they need to prescribe exercise. Case studies will be used to demonstrate exercise prescription for weight loss and to improve cardiovascular and pulmonary health.

These two sessions will run concurrently from 1:30 - 4:30 PM on the 27th. Both sessions are targeted at physiotherapists who have completed their entry-level education.

NSCP WEBSITE:

Post Graduate Education Fund:

Facility Fees:

We have been working on the annual Facility Registration process but it will take a few more weeks to complete the distribution. We will keep you posted, those concerned should be aware that at the Board meeting in October during which the 2010 Budget was approved it called for an increase in facility fees from \$25.00 to \$100.00.

Peer Review Activities:

The Peer Review committee is busy accepting member's Professional Portfolios from another 50 NSCP members for review. To date approximately 20 portfolios have been received for review. Those fifty (50) members who were randomly selected to submit their Portfolios are reminded to get their portfolios in on time. Shortly ten (10) facilities will be selected for Clinical Review by the committee as well. These will be the first Clinical Reviews undertaken by the newly trained assessors.
